

## City Tatts Ski Club Membership Terms & Conditions

### Annual fee

\$250 per adult.

### Under 18s

Free membership if at least one parent/residential caregiver is a financial ski club member.

### Eligibility

An adult must be a financial City Tatts Gold Member to join the ski club and to make a booking for Boonoona. Social members must upgrade to Gold City Tatts Membership to join City Tatts Ski Club.

### Benefits

- **Early priority booking** – Ski Club members are able to book for 2024 from **Thursday, 2<sup>nd</sup> November 2023**. General bookings open on **Monday, 4<sup>th</sup> December 2023**.
- **20% off Boonoona accommodation all season** – There are no blackout periods, but the minimum stay is two nights.
- **50% off standard rates for the historic Skiers & Swimmers Weekend** – Celebrate this time-honoured event from Friday, 30<sup>th</sup> August to Sunday, 1<sup>st</sup> September 2024. Please note the date change.
- **Complimentary access to the 2024 Snow Season Launch Party in May 2024** – This will be held at The Castlereagh. Date TBC. Guest tickets will be able to be purchased.

### Conditions

- By paying the City Tatts Ski Club membership fee, you acknowledge you have read, understand, and accept the terms and conditions.
- Early bookings cannot be made, nor can discounts be applied until the City Tatts Ski Club membership fee has been paid in full.
- City Tatts Ski Club membership is non-refundable and not transferrable.
- 2024 City Tatts Ski Club membership is valid from Thursday, 2<sup>nd</sup> November 2023 – Friday, 1<sup>st</sup> November 2024.
- Discounts cannot be applied retrospectively. Membership status is taken at the time of booking.
- For children aged under 18 to receive complimentary City Tatts Ski Club membership, at least one parent must be a financial member. This applies to carers of children who live with them. Children must travel with the adult who is a financial City Tatts Ski Club member.
- Children aged 13 years and older are served full meals and charged adult rates when staying at Boonoona, however children aged up to 18 will receive complimentary City Tatts Ski Club membership and the 20% discount if at least one parent is a financial City Tatts Ski Club member.
- The 20% discount only applies to the financial member and their children aged under 18. For example, if a man, his wife, and three children aged under 18 book into Boonoona and only the man is a financial member of City Tatts Ski Club, only he and the three children would receive the 20% discount. His wife would be charged full price.

- Bookings are subject to availability.

**Skiers & Swimmers Weekend – Friday 30<sup>th</sup> Aug to Sunday 1<sup>st</sup> Sept 2024**

- Anyone can attend Skiers & Swimmers Weekend; however, they must be a financial member of City Tatts Ski Club to receive the 50% discount on accommodation.
- The 50% discount is only for two nights Friday, 30<sup>th</sup> August – Sunday, 1<sup>st</sup> September 2024. Any additional nights will be charged at the standard rate, less the 20% City Tatts Ski Club discount.
- Bookings for 30<sup>th</sup> August – 1<sup>st</sup> September are reserved for Skiers & Swimmers Weekend participants only until the first day of the 2024 snow season (Saturday, 8<sup>th</sup> June). After that, any available rooms will be offered to the public.
